GDPR ~ Consent v4

From 25th May, 2018 all customers of A. Abbott & Sons, (Rushden) Limited must give their specific consent and indicate their various preference to personal data.


The recording of preferences must be freely given, and should be considered alongside our Privacy Policy.

We will process your data in accordance with six lawful bases

- **Contract** when processing is necessary to allow us to fulfil a contract you have with us
- **Consent** where you have given us clear permission to process your personal data for a specific purpose
- **Legitimate interest** when the processing is necessary for your legitimate interests or the legitimate interests of a third party, unless there is good reason to protect your personal data
- **Legal obligation** when the processing is necessary to comply with the law
- **Public task** when processing is necessary for us to perform a task in the public interest or for official functions, and the basis or function has a clear basis in law
- **Vital interests** when the processing is necessary to protect someone's life

The lawful basis for A. Abbott & Sons (Rushden) Ltd is processing of customer's data in relation to the contract for arranging a funeral, headstone works, floral tribute orders, pre-pain funeral plans (Golden Charter and other similar organisations) and other contracts of performance. We also have your consent preferences and have legitimate interest in the data, for potential future reference and potential legal reference and public task.

We will need to pass your data specifically to Crematoriums, Councils, Ministers, Celebrants, Church Wardens etc., Golden Charter, Florists, and other parties in order to perform the requested contract.
